Recommended Action

Approve for payment, Bender-Rosenthal Inc.'s Invoice No. 05019-1 in the amount of \$10,837.50; Kleinfelder, Inc.'s Invoice No. 242046 in the amount of \$18,365.00; MBK Engineer's Invoices 05-04-5141.1 through 05-04-5141.4 totaling \$ 18,882.58 ; and Placer Title Company's invoices totaling \$16535.00, for engineering and right-of-way services related to the execution of Phases 2 through 4 of the TRLIA Levee Repair Project

Reason for Recommended Action

The aforementioned firms have been working on a time-constrained schedule to ensure that the overall work for the three project phases proceeds according to the respective schedules. To ensure the positive cashflow that these firms would need to continue working on this tight schedule, it is imperative that they receive payment for completed work as quickly as possible once their completed invoice has been received and reviewed by TRLIA.

Discussion

Bender-Rosenthal, Inc.: Invoice No. 05019-1, dated April 22, 2005, covers Bender Rosenthal's professional services including property appraisal and right of way management, through March 2005. The total payable amount is \$62,742.22

Kleinfelder, Inc.: Invoice No. 242046, dated April 12, 2005, covers Kleinfelder's work, through April 3, 2005, towards the Phase 4 problem identification study. The total payable amount is \$18,365.00.

MBK Engineers: Invoice Nos. 05-04-5141.1 through 05-04-4141.4, dated April 28, 2005, cover MBK's professional services in carrying out hydrologic analyses and project coordination work through March 31, 2005. The total payable amount is \$18,882.58.

Placer Title Company: A total of 41 invoices have been submitted by Placer Title Company, one for each property title report they were directed to provide by Bender Rosenthal, Inc. These 41 properties represent all of the properties that are expected to be impacted by Phases 2 and 3 of the proposed TRLIA Levee Improvement Project. The total amount payable to Placer Title for the invoices is \$16,535.00.

The total amount for all of the aforementioned invoices from Bender-Rosenthal, Kleinfelder, MBK and Placer Title comes to \$116,524.80.

TRLIA staff has reviewed the subject invoices submitted by the three firms and the back-up documents (as applicable), and has determined that the charges detailed on the invoices are in conformance with the approved project scopes of work for these firms.
