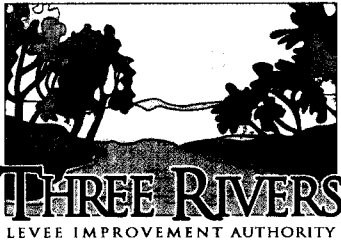

SUBJECT: Selection of Contractor to Produce TRLIA Film-Video Documentary

Recommended Action:

Delegate authority to Executive Director to negotiate, sign once General Counsel has reviewed, and then execute a professional services agreement not to exceed \$40,000 with KVIE (highest-ranking respondent) for the production of a Film-Video/Documentary explaining the history of a major program to build, fix, and maintain the levees in Reclamation District 784 area of Yuba County, California.

Discussion:

Yuba County has a long history of flooding and has endured many major levee failures that have caused havoc to Yuba County residents. The State and U.S. Army Corps of Engineers have worked for decades attempting to fix the levees, but did not succeed. Out of utter frustration, the leadership of Yuba County and Reclamation District 784 decided to tackle the problem head on and formed TRLIA in 2004 to improve the levees that protect the communities of Linda, Olivehurst, Arboga, and Plumas Lake. The charge to TRLIA was to find a way to do what the Corps of Engineers and State could not do – improve the levees in South Yuba County to withstand both the 100-year and 200-year storm events and obtain Federal Emergency Management Agency (FEMA) levee accreditation. Today, after six years of tireless effort, the levee work is nearing completion.

One way to capture this story of perseverance, dedication and foresight by a handful of visionaries is to make a video that explains the “how, what, why, where, and when” of the events that have occurred over the lifetime of the levee project. The proposed documentary will serve as a powerful tool in educating and informing the residents of Yuba County and have crossover potential to a popular viewing audience. This documentary could also be a valuable marketing tool that demonstrates the strength of leadership and commitment of Yuba County.

On August 3, the Board Authorized the Executive Director to release a RFQ for the production of a Film-Video/Documentary explaining the history of a major program to build, fix, and maintain the levees in Reclamation District 784 area of Yuba County.

On August 5, the RFQ was distributed via email and mailed to a list of reputable contractors in the Northern California region, based upon input from TRLIA’s public relations consultant and the PIOs for Sutter and Yuba Counties, among others. The RFQ was also posted to TRLIA’s website. Interested parties were given three weeks to respond.

Five responses were received by the August 27th closing date. Responses were evaluated and scored by a review committee consisting of staff and TRLIA's public relations consultant according to the following criteria:

Examples of past documentary projects accomplished by the firm within and out of the Sacramento Valley Region along with three client references, to include name, organization, address, e-mail, and telephone numbers must be submitted. These should be clients the company has done similar work for within the last five years.	20
Explanation of the firm's proposed technical approach to doing the documentary.	25
Discussion of ability to meet project schedule and stay within the proposed budget.	10
Resumes of key personnel and hourly rates	20
Total	100

The four highest-scoring firms – KVIE, Monkey & Snake, Simz Productions, and The Studio Center – were invited to participate in follow up interviews held on September 27 and 28. The interview panel included the initial review committee, along with Board Chair Mary Jane Griego and Board Member John Nicoletti. Interviewing firms were asked to provide an overview of their qualifications as per their proposals, and were again evaluated using the aforementioned criteria.

Following the interview sessions, the interview committee members individually ranked the firms for a total points ranking. KVIE received 479 points and the next ranked firm received 401 points.

In terms of overall rankings, KVIE scored four first place rankings, while Monkey & Snake had one. Simz Productions had three second-place rankings, while KVIE, Monkey & Snake, and The Studio Center each had one. Simz also had three third-place rankings, while Monkey & Snake and The Studio Center each had one.

It is recommended that TRLIA negotiate a professional services agreement for Film/Documentary Production with KVIE, the highest-ranking firm.

Fiscal Impact:

This contract would be paid for by interest that was accumulated in the TRLIA Phase 2/3 VPC Mitigation Escrow Account that was funded with developer money. In January 2010 this interest was deposited from this account to the TRLIA 805 Account.

SUBJECT: River Partners- Bear River Plant Propagation and Maintenance

Recommended Actions:

Ratify a prior 2006 \$376,049 Contract to River Partners for plant propagation and maintenance for the Bear River Setback Levee Project and delegate to Executive Director the authority to sign and execute the ratified contract including the disposal of excess plants.

Discussion:

In January of 2006, Three Rivers Executive Director, Kent McClain, executed an agreement with River Partners for Plant Propagation of plant material to be utilized for the Bear River Setback Area restoration project (see Attachment 1). This contract was recently found during a review of TRLIA prior contracts. No record of TRLIA Board approval of this contract can be located. The agreement included a provision to maintain plants beyond the projects' April 2007 project installation date on a per plant/per day basis. The amount of the work that has already been performed is as follows:

Plant Propagation – 2006	\$ 268,529
Plant Maintenance* April 2007-June 2010	<u>\$ 107,520</u>
Total Cost of Work Order	\$ 376,049

*plant maintenance contracted at the rate of \$.005/plant/day for plants held in nursery, for TRLIA after 4/1/07

River Partners performed the Bear River Setback Restoration planting in 2006 and 2007. Excess plant material was maintained per TRLIA's request, to be utilized on future TRLIA projects. TRLIA later identified the Feather River Setback Area as a potential location for the plant material. Significant portions of the plants owned by TRLIA shall be utilized in the current contract for planting in the Feather Setback Area, including the Mesick Lake Mitigation, Flood Plain Swale, and Wind Wave Buffer locations.

River Partners has prepared the attached spreadsheet(see Attachment 2) that reflects that there are 2,647 plants that do not match our current needs that are being cared for at a rate of .005

\$/plant/day = \$397/month. Staff recommends TRLIA dispose of excess plants in one of the following methods: (i) use of the plants in the Upper Yuba EIP elderberry transplant project as associates plantings; or (ii) donation of the plants to local area schools, parks, agencies.

Fiscal Impact:

The majority of the fees associated with this contract have already been expensed by TRLIA. TRLIA obtained State of California Proposition 13 Grant Funding and Developer funding that included the Bear Setback restoration and planting.

The estimated costs for plant propagation (Table 1) of the woody species are based on the proposed plant design numbers outlined in the December 2005 Riparian Restoration Plan for the Bear River Setback Levee Project.

Table 1. Estimated Costs for Woody Species Plant Propagation for the Bear River Levee Setback Project.

Timing is critical in order to have plants ready for delivery in fall of 2006. Seed collection was initiated in July 2005. To preserve any ecotype differences, plant material was collected from vegetation within the Feather River or Bear River watersheds and within a 5 mile radius from the restoration site. River Partners will deliver seed material to the nursery, Sierra Horticulture, by the end of December 2005 to begin the propagation process.

Propagation of woody species includes being grown out into 5-inch square pots. A deposit of 25% (\$67,132) is required by the nursery to initiate cultivation of the woody species at the time the plant order is contracted (on or about January 1, 2006).

These costs may change if the plant design is modified. In addition, a maintenance fee of \$0.005/plant/day will be charged for plants that remain in the nursery after April 1, 2007.

If you would like River Partners to proceed with the plant propagation, please sign this letter indicating your approval of this agreement. River Partners will then invoice TRRIA for \$67,132 and initiate a nursery contract for 92,517 plants.
