

AMENDMENT NO. 1

AGREEMENT FOR PROFESSIONAL SERVICES
FOR
ENGINEERING SERVICES
BETWEEN
THREE RIVERS LEVEE IMPROVEMENT AUTHORITY AND
CTA ENGINEERING AND SURVEYING

THIS FIRST AMENDATORY AGREEMENT is made effective August 3rd, 2010, by and between Three Rivers Levee Improvement Authority ("TRLIA") and CTA Engineering and Surveying ("the CONTRACTOR"), who agree as follows:

1. **Recitals.** This Amendment is made with reference to the following background recitals:
 - 1.1. Effective March 2, 2010 the parties entered into an Agreement for Professional Services relating to Surveying Services for TRLIA's Construction Program.
 - 1.2. Article C.24 of the AGREEMENT, states that modifications or amendments to the terms of the AGREEMENT shall be in writing and executed by both parties;
 - 1.3. TRLIA and the CONTRACTOR desire to amend the AGREEMENT;

NOW, THEREFORE, TRLIA and the CONTRACTOR agree as follows.

2. **First Amendment to Agreement.** The Professional Services Agreement is hereby amended as follows:
 - 2.1. The Termination Date in Clause 2 is amended to extend to December 31, 2011.
 - 2.2. The scope of services (Attachment A to the Agreement for Professional Services between TRLIA and CTA) is amended by the addition of effort to one of the original tasks described in the scope of services attached to this amendment as Exhibit 1.
 - 2.3. The payment, budget, and not-to-exceed amounts, described in Clause B.1 in Attachment B to the Agreement for Professional Services between TRLIA

and CTA, are amended to include the additional amount of \$14,500 for a total contract amount of \$62,000.

3. **No Effect on Other Provisions.** Except for the amendments in Section 2, the remaining provisions of the Professional Services Agreement shall be unaffected and remain in full force and effect.





Scope of Services and Fee Estimates

Right of Way Surveying Services

Scope of Services

Right of Way Line Marking
Feather River Levee

CTA Engineering & Surveying is currently under contract to provide the following surveying services:

- a) Set permanent monuments at each angle point in the property line or easement line and at a maximum spacing of 1000 feet. Monuments will be set flush with the ground and will be a 5/8" rebar with an aluminum cap or survey spike and washer for any points falling in asphalt. Each monument will be stamped with a specific designation or as directed by the client.
- b) Prepare a Record of Survey to be processed through the Yuba County Surveyor's office for recordation. All fees associated with the Record of Survey are included in the fee estimate.

Additional Services

- Set Carsonite Roadmarkers, CRM-375 or Carsonite Dual-Sided Utility Marker, CIB-380 (with decals) at 100' intervals for approximately 30,000 lineal feet of right of way. Post will be set "on-line" along the acquired right of way. The fee estimate below includes the cost for 300 posts and decals.
