Re: TRLIA 14th Quarterly Work Plan (QWP), Dated June 1, 2011.

Dear Mr. Zenobia:

Attached is the TRLIA 14th QWP covering the time period July, August, and September 2011.

The following Work Plan updates are incorporated into this Quarter Work Plan. All items listed below can be accomplished within the existing funding limits of the current Feather River EIP Agreement.

- **Project Element 1:** Additional Real Estate will be required as part of the revised Segment 3 Real Estate Plan (Feature 2). As indicated in prior Quarterly Work Plans these actions are being taken to acquire additional property rights in order to comply with three requirements:
 - 1) Central Valley Flood Protection Board's Permit No. 18170 BD, Paragraph No. Nineteen: *"The easement for Segment 3 (LM 23.6 to LM 26.1) shall, at the minimum, include the entire levee section including waterside blankets, relief wells, stability berms, and the area ten (10) feet in width adjacent to the landward levee toe if the area is not presently encumbered by a Reclamation Board easement"*.
 - 2) Current state levee 200-year Interim Levee Design Criteria requiring a minimum of 20 (twenty) feet for a landside Toe Access Corridor.
 - 3) Corps of Engineers Vegetation Policy requiring a 15 (fifteen) foot vegetation clear zone on both landside and waterside effectively establishing 15 feet on both sides of the levees.
- **Project Element 2:** Additional evaluation associated with the State's new Interim Levee Design Criteria is needed.

- **Project Element 5:** Additional work associated with evaluating the State's new Interim Levee Design Criteria is needed. Additional ROW Support costs will be incurred associated with the revised Segment 3 Real Estate Plan (Project Element 1 Feature 2). Additional construction will take place associated with completing the toe access corridor.
- **Project Element 6:** It has been determined that additional irrigation piping in the setback area requires removal, and the work will take place this quarter. Heavy rainfall over the 12th and 13th Quarters, will require repair work in the setback area. The removal of additional abandoned fruit trees will is also added.
- **Project Element 9:** Additional ROW support related to the Toe Access corridor is required as well as additional work evaluating the State's Interim Levee Design criteria.
